## Americans are rediscovering the Cooperative Difference

Your alarm clock goes off and you get out of bed. You go outside and grab the morning paper. You sit down at the kitchen table to read your paper while enjoying a glass of juice and some toast. After breakfast you head down to the local hardware store to pick up supplies to tackle your weekend to-do list.

For many Americans, that simple morning routine would bring them in contact with at least five different cooperatives.

The alarm clock could be powered by electricity from one of Minnesota's electric co-ops. The paper is likely filled with stories from the Associated Press. The juice might be Sunkist, Ocean Spray or Florida's Natural. The butter on your toast could have been processed by one of several dairy co-ops, including Dairy Farmers of America or Land-O-Lakes. If the local hardware store is a True Value, Ace or Do-It-Best, then it's part of a co-op, too.



## **CEO's Memo**

## Electricity still tops propane

Beyond basic electric service, we recognize that members have a choice of fuels for their home. For those in the Western twothirds of our service area, this typically means a choice between propane and electricity for water and space heating, your range, dryer and other key appliances.

Consequently, for these home energy decisions, Wright-Hennepin needs and wants to earn your business. You may be unsurprised to hear (but I genuinely believe it when I say): electricity is by far your best energy value. Let me explain why.

#### **Price Stability**

For most consumers, it's important to have an energy supply that is both affordable and predictable. A look at electricity's record over the past 15 years shows its price stability. Since the year 2000, the cost of ground beef has increased by approximately 59 percent, eggs by 65 percent and electricity by just 34 percent.

But a look at propane over the past 15 years shows just the opposite. It's a record of significant price swings and frequent unpredictability. While propane prices have dropped in recent months, look where they came from. As late as January of 2014, there were reports of propane users paying \$4.01 per gallon – if you could get delivery at all. Just three months earlier – in October 2013 – propane cost just \$2.37 per gallon in some areas. That's a 69 percent increase in about 90 days!

When prices come down, it can be tempting to forget the discomfort of riding the propane roller coaster. But bear in mind that, whatever the current market conditions, propane markets are historically more volatile and the long-term price trajectory is up. Still, for those who want to heat their home with electricity and propane, remember that a plenum heater allows you to switch between the two fuel sources. You can also save on electricity with a discounted rate through our dual fuel program (see page 3 for details).

#### Safety

Another huge advantage of electric appliances is improved safety. In short, you never have to worry about a gas leak. Remember that

propane appliances require venting and ductwork, which can be expensive to

install and pricey to maintain. Consequently, electric appliances tend to be less expensive over time.

#### Long-term value

Prior to this May, the basic WH monthly charge and residential member energy rate hadn't changed since 1983. In contrast, propane prices fluctuate weekly and many dealers require you to purchase propane for the entire heating season. That's an awfully large check to cut. What's more, if you overestimate your need, you risk a stranded investment. If you underestimate your usage, you may be forced to schedule a delivery at the height of a cold, unforgiving Minnesota winter. This adds its own set of risks, as many consumers learned to their dismay during the polar vortex winter of 2013-2014.

Alternatively, when you power your appliances with electricity you're getting the most bang for your buck. For every \$1 that goes into an electric appliance or heating system, you receive \$0.99 in value back in the form of electric energy. In comparison, propane or natural gas appliances lose anywhere from 10-50 percent of their heat content due to combustion and carbon monoxide venting.

Another advantage of choosing electric appliances is WH rebates. Remember, you can save up to \$1,050 on an electric water heater, or up to \$1,530 to replace your air conditioner with an air source heat pump (see page 3)!

For all these reasons – price stability, safety, long-term cost and front-end savings – electricity still remains the best value when it comes to powering your appliances. To learn more, please call our member services team at (763) 477-3000 to discuss your options.

Finally, remember that when you do business with WH, you're buying from an electric cooperative you own. Other issues aside, that might be the best advantages of all!

Dual Fuel simply allows your heating to be switched from electricity to a backup source during times of peak energy demand. In exchange, you receive a discounted rate.

#### **STEP Warmfloor heating mats**

STEP Warmfloor, from HeatMyFloors.com, is the best option for adding underfloor heat to your home if you are remodeling or planning an addition. Versatile, reliable, a low energy user and about the same thickness as a penny, STEP Warmfloor is easily installed by fastening it directly to the subfloor.

Nail and staple through it without worry. It can be used with any floor covering. You can even staple it under your floor joists and get the same results without having to remodel.

Hydronic heating systems use electric micro boilers to heat water that is then circulated through tubes embedded in a concrete slab or floor, and radiates warm, comfortable heat.



Because tubing is installed under the floor, hydronic heat is ideal for new construction.

Competitively priced, the NextGen Boiler is easy to install and requires little maintenance. The NextGen Boiler is available through contractors only.

#### **Electric Water Heater**

Electric water heaters offer unparalleled

safety and reliability because you never have to worry about a gas leak. When paired with WH's water heating program, members receive a bill credit each month for allowing WH to control charging time for heating your water overnight (11 p.m. - 7 a.m.). Members can receive

up to \$1,050 in rebates toward the purchase of a new water heater.

Qualifying water heaters may be placed on the Quick Cash Water Storage program that offers \$120 in savings annually.

#### **Plenum Heater\***

Plenum heaters are a great way to switch between electricity and other heating sources. They work by storing air in a

compartment – or plenum - which is then heated and spread throughout your home via vents. The beauty of this technology is that it allows owners to choose their fuel source for heat. This means you can take advantage of propane when its cheap, yet easily



switch back to electric heat. You can also take advantage of WH's Dual Fuel program, which offers a discounted rate of \$0.054. Also available is a \$5/

kW rebate up to \$250. However, it is up to you to find and commission your own contractor for purchasing or installing a plenum heater. WH does not sell or install them.

## Air Source Heat Pump (ASHP)

ASHPs provide heating and cooling in one efficient and economical system that looks like a central air conditioning unit (AC). In the summer, ASHPs work the same as standard ACs, cooling your



home by moving heat outside. The time when heat pumps really help save on your energy bill is during the cooler months, when the same technology is used to bring heat into your home by reversing the heat-pump process. Traditionally, WH has incentivized ACs. But given the advances in efficiency, we recommend considering an ASHP. Members can also receive up to \$1,530 in rebates toward the purchase of an ASHP. When paired with the Quick Cash Air Source Heat Pump Energy-Saving program, members receive \$30 in annual savings. Remember, you must find and commission your own contractor for purchasing or installing an ASHP. WH does not sell or install them.

## **Electric Thermal Storage**

(ETS)\* An ETS system stores thermal heat accrued overnight (11 p.m. - 7 a.m.) when energy prices are cheaper and utilizes that

heat during the day when prices are higher because of demand. There are a couple



of different types of ETS systems that you can employ to heat your home. The most common version consists of bricks made up of heating elements that serve as a storage medium. The bricks are housed in a storage heater, and the heat is distributed through thermal radiation or convection. This technology is also eligible for WH's Dual Fuel program that offers a discounted rate of \$0.054, and also features a rebate for \$5/kW up to \$250. You must find and commission your own contractor for purchasing or installing an ETS system. WH does not sell or install them.

# Wright-Hennepin returns almost \$1 million in sales tax to members

On behalf of our members, Wright-Hennepin (WH) sought and successfully

recovered refunds from the State of Minnesota for certain sales tax previously paid by its members. A portion of the payments for electric services was annually determined to be capital contributions (or member

equity), and members are allocated capital credits for contributions above the cost of electric service.

WH took the position with the state that sales tax is not payable on electric service charges that are later determined to be capital contributions. We therefore requested a refund from the state.

After a contested case, a decision was reached which determined that refunds for certain years would be allowed. Refunds totaling almost \$1 million were distributed to qualifying members and former members in the form of a check, or a bill credit for current members if it is less than \$20.

## Important information for members on energy-saving and off-peak programs

This month, WH will switch its summer energy-saving cycling to winter load management beginning October 20. Instead of air conditioning, Dual Fuel heating will be managed during times of peak energy demand after this date.

To ensure backup heating systems turn on during periods of load management, two tests will be completed during the month of October. The first test will run October 20 and the second will run October 22. Both tests will take place between 6 p.m. and 9 p.m.

During this test period, members should make sure their backup heating system

functions properly. Members enrolled in WH's Dual Fuel program can expect to have their heat managed only during peak demand times after October 22.

Also, if you're one of many Minnesotans who head south for the winter and are on one of WH's Off-Peak metered programs, please know that turning off any breaker may disconnect your energy-saving meter. If this happens, you will be charged the regular rate instead of the discounted energy-saving rate, as the meter will be unable to record the energy-saving usage.

Since not all meters have been wired in the same manner, it is hard to determine who this will affect. If you are heading south for the winter and plan to turn your breaker/ power off and think it may affect your energy-saving meter, we suggest having a licensed electrician review your system's wiring.

## Cold Weather Rule goes into effect October 15


t's time to remind all Wright-Hennepin (WH) members about Minnesota's Cold Weather Rule, which is designed to keep families warm during winter, especially those who may have challenges paying their monthly bill.

Per the Cold Weather Rule, WH must not disconnect and must reconnect the utility service of a residential member during the period of October 15 to April 15 if the disconnection affects the primary heat source for the residence and all of the following conditions are met:

- The member enters into, and makes reasonably timely payments, under a payment agreement that considers the financial resources of the household.
- The member receives referrals to energy assistance, weatherization, conservation or other programs likely to reduce the member's energy bills.
- The household income of the member is at or below 50 percent of the state median household income. The utility may verify income on forms it provides, or obtain verification of income from the local energy assistance provider. A member is deemed to meet the income requirements of this clause if the member receives any form of public assistance that uses an income eligibility threshold set at or below 50 percent of the state median household income.
- Unpaid bills must be absorbed by members who faithfully pay their bill each month. WH does not want to interrupt service of any member, but all members suffer when a bill remains unpaid.



If you cannot pay your electric bill, are having financial difficulties or do not meet state guidelines for cold weather protection, please contact WH's credit team at (763) 477-3000 to set up an acceptable payment agreement.



## Winter construction charges

Wright-Hennepin (WH) would like to remind members that if you are planning to run electric service to a home, outbuilding or other facility, please be aware that additional winter charges may apply between November 15 and April 15.

You can avoid winter construction charges by having your site ready for service installation prior to November 15.

## Sales tax exemption available for members

ou may be exempt from state and local sales tax during the heating season if your primary residential heat source is electricity.

If more than 50 percent of the main heat source for a residence comes from purchased electricity, you are exempt from Minnesota and local sales tax during the months of November through April.

All electricity used through the same meter, whether for heating purposes or not, is also exempt throughout this six-month time period.

Wright-Hennepin (WH) can provide you with this exemption when you complete the online form at http://goo.gl/6khNcP, or call (763) 477-3000 to have a paper copy sent to you. You do not need to re-submit the form if you have previously submitted one. If you have changed your method of heating since filling out the form, please notify us so you can be removed from the program.

## Make fire safety a priority this October

n 2015 alone there were 1,345,500 fires reported in the U.S., resulting in \$14.3 billion in property damage, according to the National Fire Prevention Agency (NFPA).

October 9-15 is National Fire Prevention Week, and the entire month is recognized as Fire Prevention Month due to the amount of damage and injuries attributed to fires every year.

Smoke alarms are one of the easiest and most effective ways to practice fire safety. According to the NFPA, working smoke alarms cut the risk of dying in home fires in half.

Regular smoke detectors are great for alerting you to a fire when you're home, but what about when you're away from your residence? Monitored smoke detectors offered through WH Security notify the security monitoring center whenever an alarm is triggered. This service is provided regardless of whether your alarm is set, and at no added cost for monitoring. The monitoring center is then able to dispatch the proper authorities.

Here are some tips for preventing fires and staying prepared:

#### **Prevention:**

- Never leave a candle burning unattended.
- Keep matches, gasoline and lighters in a safe place away from children.
- Never leave a hot oven or stovetop unattended.
- Keep space heaters at least three feet away from furniture and flammable objects.
- Avoid plugging multiple appliances into the same electrical outlet, and do not use extension cords or outlets that have exposed wires, burn marks or other visible damage.

#### How to stay prepared:

• Test smoke detectors monthly and clean them if needed.
