# In the season of giving, Wright-Hennepin gives \$3.6 million back to its members

For the third year in a row, Wright-Hennepin (WH) is breaking records with the largest general retirement ever returned in the history of the cooperative. To cap off 2017, WH is proud to announce a \$3.6 million capital credit refund to members! This marks the 37th consecutive year that WH has returned capital credits to members. Members who purchased electricity from WH in 1993, 1994 and a portion of 2016 will receive a capital credit refund, as declared by WH's Board of Directors. Members will receive a check in the mail if their refund is \$5 or greater unless they have opted to receive a bill credit (see your December bill insert or go online at whe.org). Members whose refund is between \$1.00 and \$4.99 will automatically receive a bill credit instead of a check.

WH is a not-for-profit cooperative owned by the members it serves. Our mission is to provide electric power at the cost of service. Any remaining "margins" collected after operating expenses are returned to you, the member-owners. Before returning margins back to members, WH uses the capital to offset the cost of maintenance and construction of the electric distribution system.

"We're happy to show our members the value of their ownership through capital credits," said WH Board Chair Erick Heinz. "Based on the co-op's strong financial performance, we're pleased to return greater margins to our members for the third straight year."

# **CEO's Memo**

Tim Sullivan, WH President and CEO

## Mom Was Right: Safety First!

As Mom used to say: "It's all fine until someone gets hurt." And as usual, Mom was right—and her advice is especially worth heeding when it comes to electricity and electric safety.

Thankfully, given the billions of interactions each year, electricity's safety record is quite strong. But given the stakes, there are times when we must all exercise a special level of care. Consider:

- A summer thunderstorm knocks down a utility pole in your yard or across your street.
- You're doing a home improvement project involving "just a small wiring change."
- You're moving metal equipment, perhaps even a small step ladder, near a power-line.

These are just three common scenarios. But they highlight the importance of electrical safety awareness and education something we take very seriously not only for our employees but for our members.

Our commitment to safety starts with our employees. Bear in mind the scope of this responsibility: Wright-Hennepin (WH) puts 80 vehicles on the road every day to help manage 24,000 transformers, 41,000 poles, 4,000 miles of line and 27 substations. Consequently, our commitment to safe equipment and training must be commensurate with this scale. Consider just a few of our practices:

- Our bucket trucks are inspected twice a year by an expert third party. Our drivers also conduct daily inspections.
- WH line crews are required to wear a variety of protective clothing, including a hard hat, safety glasses, insulated gloves and protective boots. Our rubber gloves are tested by a certified testing laboratory on a 30-day rotation.
- We implement a preventive maintenance program to find hot spots on our lines before they become an issue. WH inspects substations monthly, overhead lines annually and pad-mounted equipment (ground

level boxes) every five years. We conduct detailed inspections of utility poles on a 10-year rotation.

A safe work environment also means a commitment to safe procedures. We use "Lockout-Tagout" procedures to ensure circuit breakers, fuses and other disconnecting devices are properly shut off and locked out until maintenance or servicing work is complete downline. When a lineman works on a power line, the fuse or breaker is opened, de-energized and grounded and a tag is attached identifying the worker who placed it. The worker placing the tag is the only one who is allowed to remove it, preventing an accidental or hazardous incident.

Safety also depends on training. Our line crews attend a dozen safety training sessions and our internal office staff must attend four training sessions every year. To help us manage this, WH employs a full-time Safety Director in conjunction with our sister system, Minnesota Valley Electric Cooperative.

Our commitment to safety also extends to our members and the public at large. We promote safety awareness and education by conducting at least 30 Hotline Demonstrations each year. At these events, our employees speak to school children and community groups about the importance of practicing safety around the home and near power lines.

So, how are we doing? A key measure of employee safety in our industry is the "Days Away, Restricted Time" (DART) rate. Essentially, it measures lost time due to safety incidents. We're proud to say that, in three of the past five years, WH has performed among the country's top cooperatives. Through the first three quarters of 2017, we are on pace for a perfect DART rate.

Our commitment to safety starts at the very top, with our WH Board of Directors. They have challenged us to achieve safety performance among the top-10 percent among all electric co-ops in the country. So, our real goal is not only fewer incidents but zero incidents, zero lost time, zero injuries — all part of what we call the Quest for Zero. To achieve this, we know we must

#### **Board Report** October Board Meeting Highlights:

The Wright-Hennepin and WH Holding monthly Board of Director meeting was conducted on October 16, 2017. A quorum of directors was present. Items discussed or Board action taken:

- Reviewed the annual write-off of bad debt.
- Heard reports from directors on recent industry meetings.
- Heard a report on hydrogen fuel cell technology for motor vehicles.
- Reviewed and filed the monthly CEO, legal, financial and operations reports.
- Guests included: Mike Steffes and Zac Edstrom from ACES, who shared the outlook on the Midcontinent Independent System Operator (MISO) market.

## Announcing Wright-Hennepin's 2018 Scholarships

The school year is nearly halfway complete and it's never too early to get a jump on scholarship applications. Wright-Hennepin (WH) is once again offering scholarships to students in the service area who are cooperative members.

The following scholarships are awarded and funded on behalf of WH and WH Holding through unclaimed capital credits and a contribution from WH Holding.

#### WH Local Schools Scholarships

WH will award a scholarship to one student whose family is a cooperative member at each of the following public schools in WH's service territory: Annandale, Buffalo, Dassel-Cokato, Delano, Howard Lake-Waverly-Winsted, Maple Grove, Maple Lake, Monticello, Orono, Osseo, Rockford, Rogers, St. Michael-Albertville, Watertown-Mayer, Wayzata and Wright Technical Center. WH also offers one "at-large" scholarship to students and cooperative members' students from private or home schools within, and schools that neighbor, WH's service territory. Each school listed has its own application deadline. The "at-large" application deadline is April 2, 2018.

#### Edward R. Slebiska Memorial Line Worker Scholarship

Each year, WH awards two \$3,000 scholarships to students pursuing the line worker profession to honor the memory of Ed Slebiska, the cooperative's first CEO. This scholarship is open to high school seniors or older living within a 30-mile radius of Rockford. Enrollment in a Power Line Technical College is required.

The application deadline for this scholarship is April 15, 2018.

#### Basin Electric Power Cooperative Scholarship

Basin Electric Power Cooperative of Bismarck, N.D., will award a \$1,000 scholarship to dependents of WH members or descendants of employees who work at the cooperative. Basin is one of WH's power suppliers. The application deadline for this scholarship is February 9, 2018.

# Electricity remains a great value

Electricity continues to be a good value for the money and Wright-Hennepin (WH) works hard to keep costs at a minimum for our members.

The cost of powering your home rises at a similar pace to many other typical expenses. According to the U.S. Bureau of Labor Statistics Consumer Price Index, over a five-year span from 2011 to 2016, medical care costs rose 3 percent per year, average rent prices rose 3.3 percent per year, the cost of education rose 3.4 percent per year and the price of a pound of ground beef rose 4.1 percent per year. Meanwhile, during the same time period, the cost of electricity for WH members rose an average of 3.38 percent per year since 2011, and rose just 1.02 percent in 2017.

Another way to look at the cost of electricity is to consider the \$4 you might spend on a cup of coffee purchased from a coffee shop. That same \$4 would allow you to charge a smart-phone once per day for 14 years, run an air conditioner for 10 straight hours or watch television for four hours a day for 50 days.

# **Directors Lindenfelser and Tieva earn CCD Certificate**

To receive this certificate, directors must attend five courses and successfully complete a learning assessment for each. One of the key strengths of NRECA is its commitment to education and professional development. Of more than 7,200 active directors in the rural electric program today, nearly 65 percent have earned their CCD.

## **Local Democracy Update**

Wright-Hennepin's (WH) Board of Directors decided at its October 16, 2017 meeting, to assume the distributed generator dispute and resolution originally delegated to the Public Utilities Commission (PUC). The Board determined this advanced the best interests of members. This authority now extends to Minnesota Statute Section 216B.164 (the "Co-generation Section"), concerning Co-generation and Small Power Production; within the co-ops service territory. The Cooperative is now exempt from regulation by the PUC under the Co-generation Section. Additional information can be found on our website at http://goo.gl/biWi9L.

The PURPA (Public Utilities Regulatory Policies Act) of 1978 states that Wright-Hennepin (WH) is obligated to interconnect with and purchase electricity from co-generators and small power producers. WH will provide information on its PURPA policies to all interested persons free of charge upon request. Any disputes over interconnection, sales, and purchases are subject to resolution by WH. # Beware of the freeze!

When the temperature begins to drop, it's time to think about the effect weather can have on our homes. For those of us who enjoy a winter vacation or those who leave the cold behind for an extended trip south, the cold Minnesota winters could potentially lead to thousands of dollars in damages to your home.

If the heat goes out in your home, the temperature may drop significantly, which could cause pipes to freeze and burst. A burst pipe will spray water, which can ruin floors, walls, appliances and possessions. WH Security offers freeze sensor technology that is designed to detect temperature drops in the home, alerting you to the potential of damage occurring.

How does it work? These environmental sensors are mounted in your home, often under the kitchen sink, and detect if the in-home temperature drops below 42 degrees. If this happens, the sensor alerts our monitoring center. Dispatchers will then inform you of the situation so you can take action to warm up your home before the pipes freeze and burst.

Freeze sensors are affordable to purchase and install and do not increase the monthly monitoring cost. Snowbirds who travel south for the winter, yet still maintain a Minnesota home, find these sensors especially helpful. Installing a temperature drop sensor to your monitored alarm system allows less worry about your vacant home letting you enjoy your time away from the cold even more.

Instead of relying on someone to check your home while you are away, let WH Security monitor it for you. Contact a WH Security representative for more details.

## 😑 ORU helps families in need

An Operation Round Up (ORU) grant awarded to the Buffalo Rotary is helping families in Buffalo and Montrose this winter. Every Christmas for more than 15 years, the Rotary organizes the Adopt-A-Family program in which children 17 and under and disabled adults in need are provided with necessities like shoes, boots, coats, hats, mittens, pajamas, socks, underwear and clothing. While the Toys for Tots program provides toys and games to children in need, the Adopt A Family program provides clothing necessities.

Last year, the program helped a record 160 families (419 children) from the Buffalo and Montrose communities have a better Christmas — and the number is expected to grow this season.

Through the Adopt A Family program, families in need sign up for assistance or are referred to the program by others. They request specific items, sizes and colors and organizers do their best to provide exactly what they need. Individuals in those communities also volunteer to "adopt" a family in need and purchase the items on these wish lists. But those in need regularly exceed the list of those willing to help, which is where the ORU grant comes in.

"Without ORU's donation, we would not be able to fulfill the need of our community and we are incredibly grateful for the support!" said Sally Stevens, Buffalo Rotarian.

ORU recently awarded the Buffalo Rotary a grant for \$5,000 with \$4,000 going to the Adopt A Family program. The remaining \$1,000 will be used to support the Students Taking Renewed Interest in the Value of Education (STRIVE) program at Buffalo High School, which is a one-to-one mentoring program focused on motivating at risk high school juniors and seniors.
