Rebates are available for EV wall mount charging stations (Level 2) purchased on or after January 1, 2022. The charging station must be installed where electricity is supplied by Wright-Hennepin (WH) and controlled on an ESP. Rebate submittal must follow the guidelines as outlined by WH. WH is not responsible for inaccurate information supplied by vendors. Rebate program is subject to change or cancellation without notice. Call WH at (763) 477-3000 to verify rebate program status.

I certify that the EV charging station for which I am claiming a rebate is a qualifying charging station with an all-electric EV having a minimum of a 4.5 charger rating. The EV charging station is installed at the address listed above and the address represents a valid WH electric account.

## Important:

- This form is valid for the purchase/installation of either a bring your own charging station or a ZEFNET charging station.
- Bring your own EV charging station will be required to be on the Electric Vehicle Storage Charge program or the Time of Use program.
- The ZEFNET charging station will be required to be on the EV Storage Charge ESP.
- Rebate amount is up to \$500 toward the purchase/installation of a 240-volt Level 2 wall mount charging station.
- The EV is required to be fully electric with a minimum of 4.5 kW charger rating.
- The EV charging station must be installed within WH's electric service territory.
- One EV program rebate per household for life.
- Using additional outlets for the EV that are not connected to an ESP are prohibited when participating in the storage program.
- If bringing your own charging station, the ESP meter and receiver equipment must be located outside of the home.
- If installing a ZEFNET charging station the meter and receiver equipment are integrated into the charging station.
- EV Storage Charge ESP charging time is eight hours per day, generally from 11 p.m. - 7 a.m. Charging is not available all other hours. Energy rate is \$.06434 per kWh. The energy rate will not be subject to Power Cost Adjustment (PCA).
- EV Time-of-Use ESP charging rate varies based on physical location of equipment and time of day. All energy sold under Time-of-Use will not be subject to the PCA rider.
- Member will pay the cost and arrange installation for all special equipment and/or additional switching mechanism necessary to meter the charging station.
- Fill out this form completely. Incomplete forms will not be processed.
- Include your account number and sign the form.
- Rebate dollars are limited and will be paid on a first-come, first-served basis.
- Rebates will be issued as a credit on your WH electric bill.
- The program will be required to be in place for a minimum of five years. If removed, the rebate will be prorated and billed to your electric account.
- Please allow six to eight weeks for rebate processing after ESP installation.
- **Equipment must be purchased between January - December 31, 2022.** Submit completed rebate form and a copy of the original sales receipt within 90 days of installation date to:
