Ground Source Heat Pump Energy Saving Program (closed loop systems only)

This rebate is available only for the purchase of a new Ground Source Heat Pump (GSHP). The GSHP must be installed where electricity is supplied by Wright-Hennepin (WH). GSHP must be placed on the GSHP uncontrolled \$.099 rate Energy-Saving Program (ESP). Rebate submittal must follow the terms as outlined on this form.

Terms of the WH Energy-Saving Rebate Program

- Rebate amount is \$125 per ton for the qualifying GSHP. Rebate is limited to a maximum of 6 tons per system.
- Rebates will be issued as a credit on your WH electric bill.
- GSHP must be installed within WH service territory.
- GSHP will be the member's primary heating source (closed loop systems only).
- GSHP must be on the Uncontrolled GSHP ESP.
- The GSHP will not be subject to interruption.
- Energy will be sold for the GSHP at \$.099/kWh. The energy sold for this program will not be subject to the Power Cost Adjustment.

- Any supplemental electrical heat sources (duct heaters, boilers, baseboard) will not qualify for the GSHP rate and must be placed on the Dual Fuel program and metered separately.
- Member will pay the cost and arrange installation for all special equipment and/or additional switching mechanism necessary to meter the heat pump system and supplemental heat.
- The ESP metering equipment will need to be located outside the home.
- Contact WH at (763) 477-3000 for final ESP inspection. ESP rates and rebates will not be applied until final inspection is completed.
- If electricity is your primary source of heating your home, you are eligible to receive a sales tax exemption. Forms can be found at whe.org.
- **Please allow six to eight weeks for rebate processing after ESP installation.**
- **The ESP for the GSHP will be required to be in place for a minimum of five years.**
- **By applying for the rebate you are agreeing to the terms of the program.**
- **Must be purchased between January 1 - December 31, 2023. Submit the completed rebate form and a copy of the original sales receipt within 90 days of purchase to:**
