### Terms of Residential Conservation Improvement Rebate Program

- Rebate amount is \$50 per qualifying ECM. Maximum rebate on (2) qualifying ECMs.
- Rebates will be issued as a credit on your Wright-Hennepin (WH) electric bill.
- ECM must be installed within WH's service territory.
- Rebates are available to residential members who install HVAC equipment with an ECM.
- ECM rebate applies only on replacement or retrofit. New construction is not eligible.
- **Rebate dollars are limited and will be paid on a first-come, first-served basis.**
- **Fill out this form completely. Incomplete forms will be returned.**
- **Please allow six to eight weeks for rebate processing.**
- **Equipment must be purchased between January - December 31, 2024.** Submit completed rebate form and a copy of the original sales receipt within 90 days of purchase date to:
