- Rebate amount is up to \$200 for qualifying Variable Speed Pool Pumps with an EF greater than or equal to 3.8 for the most efficient speed.
- Limit of one rebate each per member account.
- Equipment must be installed within Wright-Hennepin's (WH) service territory.
- Rebates will be issued as a credit on your WH electric bill.
- Fill out this form completely. **Form must be signed by the WH member applying for the rebate.** Incomplete forms will be returned.
- Please allow six to eight weeks for rebate processing.
- Equipment must be purchased between January 1 - December 31, 2025. Submit completed rebate form and a copy of the original sales receipt within 90 days of installation date to:
