Terms of WH rebate program

- Rebate amount is \$15 per kW on the tank, maximum is 4.5 kW.
- Rebates will be issued as a credit on your Wright-Hennepin (WH) electric bill.
- · Water heater must be installed within WH service territory.
- Water heater must be on the Peak Shave Water Heating Energy-Saving Program (ESP).
- Water heater control times are limited to eight hours per day, only during peak demand times.
- · Water heater will be metered at the general service rate.
- A credit of \$5 will be applied to the member's electric account monthly. The member must have a minimum general service usage of 300 kWh per month to qualify for the credit.
- This program is available on a limited basis and will require approval for participation.
- · Member is responsible for water heater installation cost and maintenance of the water heater.
- WH will provide installation of the load control device. WH will only pay for the standard installation of the load control device for the Peak Shave Water Heating Program.
- The ESP receiver equipment will need to be located outside the home.

Terms, continued

- · Hot Water Recirculation units (gravity or pumped) are not recommended to be used with the water heating programs.
- Humidifiers must be plumbed into a cold water source.
- Fill out this rebate form completely. Form must be signed by the WH member applying for the rebate. Incomplete forms will be returned.
- Contact WH at (763) 477-3000 for final ESP inspection. ESP rates and rebates will not be applied until final inspection is completed.
- Please allow six to eight weeks for rebate processing after ESP installation.
- The ESP for the water heater will be required to be in place for a minimum of five years. If removed, the rebate will be prorated and billed to your electric account.
- By applying for the rebate you are agreeing to the terms of the program.
- Must be purchased between January 1 December 31, 2025. Submit the completed rebate form and a copy of the original sales receipt within 90 days of purchase to:

Rebates are available only for the purchase of new 52-gallon or greater electric water heater on or after January 1, 2025. Rebate dollars are limited and will be paid on a first-come, first-served basis. The water heater must be installed where electricity is supplied by WH. Rebate submittal must follow the guidelines as outlined by WH. WH is not responsible for inaccurate information supplied by vendors. The rate/credit and rebate offered by this program are subject to change without notice. By participating in this program, participants acknowledge that the pricing and rebate amounts are not fixed and may be adjusted in the future. Participants accept any such changes to the program.
