## General program rules and information

- All applicable rebate forms or worksheets must be completed and submitted by the applicant.
- Qualification and funding criteria for this rebate incentive program is defined per the “Rules and Information” page attached.
- Funding for efficiency-improvement projects is subject to status of rebate program budget at time of application.
- For consideration, rebate applications must be submitted to WH no later than November 1, 2026. The commercial member is responsible for checking with WH to quantify program funding availability, and to resolve any questions regarding program rules or criteria. Project pre-approval by the cooperative is highly recommended.
- Equipment installation must be complete in order for rebate funds to be issued.
- Members (or vendors acting on behalf of) must complete and submit both the Applicant Information Page and Rebate Worksheet page as contained within this application.
- Rebate incentives must be applied for within 12 months of the applicable project’s invoice date.
- The cooperative reserves the right to conduct random inspection of installations.
- Unless otherwise approved by WH, the maximum per-project RTU/Split-system rebate incentive is \$5,000.
- In all cases, the cooperative reserves the right to determine the maximum rebate amount issued.

## Documentation requirements

- The stated RTU efficiency rating needs to reflect that value as is certified by AHRI. For split-system units, the average efficiency rating as determined by AHRI should be utilized.
- Documentation confirming purchase of stated equipment must be provided as reflecting name of manufacturer, model number, efficiency rating, and per-unit cost.
- Acceptable forms of documentation provided can be a copy of applicable purchase order, project invoice, or similar item-of-record.

# 2025 RTU and split-systems rebate rules and information

## Completion directions

- In the left column of the chart below, find the tonnage rating for relative RTU or split-system cooling unit.
- To the immediate right of the unit's rated tonnage, find the efficiency range as is applicable to the new or replacement cooling unit.
- The applicable rebate incentive will be the value in the table where the relevant tonnage and efficiency range of cooling unit intersect. *For example: A 4-ton unit with a 14.8 SEER rating would qualify for a \$114 rebate incentive.*
- To apply for an incentive, enter the appropriate rebate value and specific cooling unit data into the worksheet below.
- For additional/differing cooling units, repeat the steps above under an additional item number.
- Upon all required data being entered, the total applicable incentive amount will be indicated.
- Refer to the Rules and Information page for specific details concerning rebate program submission requirements and funding parameters.
