### Terms of Residential ECO Program

- Rebate amount is \$400 for qualifying Uncontrolled Ducted or Ductless Air Source Heat Pumps with fossil fuels as the primary heat source.
- Qualifying units for this rebate do not have utility curtailment or have a proprietary thermostat that does not allow WH to manage the unit under the Quick Cash Air Source Heat Pump Program.
- Rebate will be issued as a credit on your Wright-Hennepin (WH) electric bill.
- Uncontrolled Air Source Heat Pump unit must be installed within WH's service territory.
- Uncontrolled Air Source Heat Pump unit must be a new  $\geq$  14.3 SEER2 Air Source Heat Pump.
- If there is more than one electric panel in your home, please verify that the ASHP breaker is in the general service panel.
- Fill out this form completely. Incomplete forms will be returned.
- Please allow six to eight weeks for rebate processing.
- Limit one rebate per member account. Rebate cannot be combined with Quick Cash Air Source Heat Pump rebate.
