### Terms of Residential ECO Program

- Rebate amount is \$325 per ton for the qualifying GSHP. Rebate is limited to a maximum of 6 tons.
- Rebates will be issued as a credit on your Wright-Hennepin (WH) electric bill.
- GSHP must be installed within WH service territory.
- GSHP will be the member's primary heating source (closed loop systems only).
- GSHP must be on the Uncontrolled GSHP Energy-Saving Program (ESP) to qualify for rebate.
- The GSHP will not be subject to interruption.
- Energy will be sold at the current Uncontrolled Ground Source Heat Pump Rate. The energy sold for this program will not be subject to the Power Cost Adjustment (PCA).
- The ESP meter equipment will need to be located outside the home.
- If you also have any electric supplemental heat, it must be separately metered and controlled on a Dual Fuel rate strategy.

### Terms, continued

- Member will pay the cost and arrange installation for all special equipment and/or additional switching mechanism necessary to meter the heat pump system and supplemental heat.
- If electricity is the primary source of heating your home, you are eligible to receive a sales tax exemption. Find the form at [bit.ly/WH-tax-exemption](http://bit.ly/WH-tax-exemption).
- By applying for this rebate, you are agreeing to the terms of the program.
- The program will be required to be in place for a minimum of five years. If removed, the rebate will be prorated and billed to your electric account.
- Fill out this form completely. **Form must be signed by the WH member applying for the rebate.** Incomplete forms will be returned.
- Contact WH at (763) 477-3000 for final ESP inspection. ESP rates and rebates will not be applied until final inspection is completed.
- Please allow six to eight weeks for rebate processing after ESP installation and inspection.
- Equipment must be purchased between January 1 - December 31, 2026. Submit completed rebate form and a copy of the original sales receipt within 90 days of purchase date to:

Rebates are available only for the purchase of new GSHP. Rebate dollars are limited and will be paid on a first-come, first-served basis. The GSHP must be installed where electricity is supplied by Wright-Hennepin (WH). Rebate submittal must follow guidelines as outlined by WH. WH is not responsible for inaccurate information supplied by vendors. The rate/credit and rebate offered by this program are subject to change without notice. By participating in this program, participants acknowledge that the pricing and rebate amounts are not fixed and may be adjusted in the future. Participants accept any such changes to the program.
