- Electric lawn tool must be used within WH service territory.
- Please allow six to eight weeks for rebate processing.

- Electric lawn tool(s) must be purchased between January 1- December 31, 2026. Submit the completed rebate form and a copy of the original sales receipt within 90 days of purchase to:
