Terms of WH rebate program

- Rebate amount is \$40/kW for qualifying Dual Fuel Program participation. Minimum of 4.5 kW load connection required, maximum 20 kW per system.
- Rebates will be issued as a credit on your Wright-Hennepin (WH) electric bill.
- The Dual Fuel equipment must be installed within WH's service territory.
- The Dual Fuel heating system will be on the metered Dual Fuel Energy-Saving Program (ESP).
- The ESP meter and receiver equipment will need to be located outside the home.
- Contact WH at (763) 477-3000 for final ESP inspection. ESP rates and rebates will not be applied until final inspection is completed.
- Portable heaters, wood burning stoves and electric space heaters DO NOT qualify as a backup heat source.
- If electricity is your primary source of heating your home, you may be eligible to receive a sales tax exemption. Find the form at bit.ly/WH-tax-exemption.
- The program will be required to be in place for a minimum of five years. If removed, the rebate will be prorated and billed to your electric account.
- Fill out this form completely. **Form must be signed by the WH member applying for the rebate.** Incomplete forms will be returned.
- Please allow six to eight weeks for rebate processing after ESP installation and inspection.

Terms, continued

- Equipment must be purchased between January 1 - December 31, 2026. Submit completed rebate form and a copy of the original sales receipt within 90 days of installation date to:

Rebates are available only for members participating in the Dual Fuel Program. Rebate dollars are limited and will be paid on a first-come, first-served basis. The program must be installed where electricity is supplied by WH. Rebate submittal must follow the guidelines as outlined by WH. WH is not responsible for inaccurate information supplied by vendors. The rate/credit and rebate offered by this program are subject to change without notice. By participating in this program, participants acknowledge that the pricing and rebate amounts are not fixed and may be adjusted in the future. Participants accept any such changes to the program.
