#### Terms of WH rebate program

- Charging station must be a Level 2 hardwired, 240-volt, wall mounted unit.
- Rebate amount is up to \$500 toward the purchase/installation of a hardwired, 240-volt, Level 2 wall-mount charging station for an all-electric battery electric vehicle (BEV) with a minimum of a 4.5 kW charger rating.
- Rebate amount is up to \$150 toward the purchase/installation of a hardwired, 240-volt, Level 2 wall-mount charging station for a plug-in hybrid electric vehicle (PHEV) with a minimum of a 4.5 kW charger rating.
- EV charging station will be required to be on the Time of Use (TOU) Program through Wright-Hennepin (WH).
- The EV charging station must be installed within WH's electric service territory at an address that receives electricity from WH.
- One EV program rebate per household for life.
- Using additional outlets that are not connected to an Energy-Saving Program (ESP) for charging the electric vehicle is prohibited.
- The ESP meter must be located outside of the home.
- Contact WH at (763) 477-3000 for final ESP inspection. ESP rates and rebates will not be applied until final inspection is completed.
- Member will pay the cost and arrange installation for all special equipment and/or additional switching mechanism necessary to meter the charging station.

## Terms, continued

- Fill out this form completely. **Form must be signed by the WH member applying for the rebate.** Incomplete forms will be returned.
- Rebates will be issued as a credit on your WH electric bill.
- The program will be required to be in place for a minimum of five years. If removed or not being used, the rebate will be prorated and billed to your electric account.
- Please allow six to eight weeks for rebate processing after ESP installation and inspection.
- Equipment must be purchased between January 1 - December 31, 2026. Submit completed rebate form and a copy of the original sales receipt within 90 days of installation date to:

Rebates are available for Level 2 hardwired, 240-volt, wall mounted EV charging stations. Rebate dollars are limited and will be paid on a first-come, first-served basis. The charging station must be installed where electricity is supplied by Wright-Hennepin (WH) and enrolled in the Time of Use Energy-Saving Program. Rebate submittal must follow the guidelines as outlined by WH. WH is not responsible for inaccurate information supplied by vendors. The rate/credit and rebate offered by this program are subject to change without notice. By participating in this program, participants acknowledge that the pricing and rebate amounts are not fixed and may be adjusted in the future. Participants accept any such changes to the program. Call WH at (763) 477-3000 to verify rebate program status.
