

WRIGHT-HENNEPIN GENERAL SERVICE TIME-OF-USE SERVICE RATE (TOU)

I. *Availability*

A. Residential and Single-Phase Agricultural

1. Available to agricultural members with single-phase electrical service and all residential members.
2. The rate applies on a per dwelling basis for both single and multi-dwelling residences.

B. Small Commercial and/or Industrial and Multi-Phase Agricultural

1. Available to small commercial and/or industrial and multi-phase agricultural members meeting the following criteria:
 - a. Members with single-phase service having recorded monthly energy usage less than 15,000 kWh. If the member exceeds 15,000 kWh per month for 4 months or more during the preceding calendar year, the account shall be transferred to the Commercial and Industrial (CI) rate.
 - b. Members with multi-phase service having recorded monthly energy usage of less than 5,000 kWh or a demand reading of less than 25 kW. If a multi-phase member on this rate records both a monthly energy usage of 5,000 kWh or more and a demand reading of 25 kW or more for 4 months or more during the preceding calendar year, the account shall be transferred to the CI rate.

C. Electric Vehicle

1. Any new standalone service dedicated to Electric Vehicle (EV) charging must be on this TOU Rate.
 - a. Rate applies to both single and multi-phase services located at residential, multi-family, commercial and industrial.
 - b. Requirement participation is for dedicated services only.
 - c. Dedicated EV services will incur a basic charge.



II. *Type of Service*

- A. Single-phase or multi-phase, 60 hertz, at available secondary voltages, through a single meter.

III. *Monthly Rate*

- A. Basic Charge
 - 1. \$19.90 per month for transformers less than or equal to 50 kVa
 - 2. \$42.00 per month for transformers greater than 50 kVa
- B. Energy Charge closed to members with an Eaton Meter
 - 1. 12:00 PM to 10:00 PM @ \$0.31171 per kWh
 - 2. All other hours @ \$0.06434 per kWh
- C. Energy Charge for members with an Eaton Meter
 - 1. 5:00 PM to 10:00 PM @ \$0.31171 per kWh
 - 2. 5:00 AM to 5:00 PM @ \$0.13213 per kWh
 - 3. 10:00 PM to 5:00 AM @ \$0.06434 per kWh

IV. *Power Cost Adjustment*

All energy sold under this rate will not be subject to the Power Cost Adjustment (PCA) Rider.

V. *Minimum Monthly Bill for EV*

The minimum monthly bill shall be the Basic Charge. For members requiring additional capacity, the minimum will be increased by \$0.75 for each additional kVa or, as calculated by the Cooperative to recover the cost of investment in facilities necessary to provide the required capacity, whichever is greater.

VI. *Minimum Connection Period*

- A. The account will remain connected under this TOU rate for a minimum of one year or until the account is transferred. If an account has been disconnected for a period of less than one year and the account is to be reconnected, the member shall pay the minimum bill for the months the service was disconnected, plus the applicable service charge. If an account is disconnected more than six months, an electrical inspection is required, at member's expense, prior to reconnection.
